

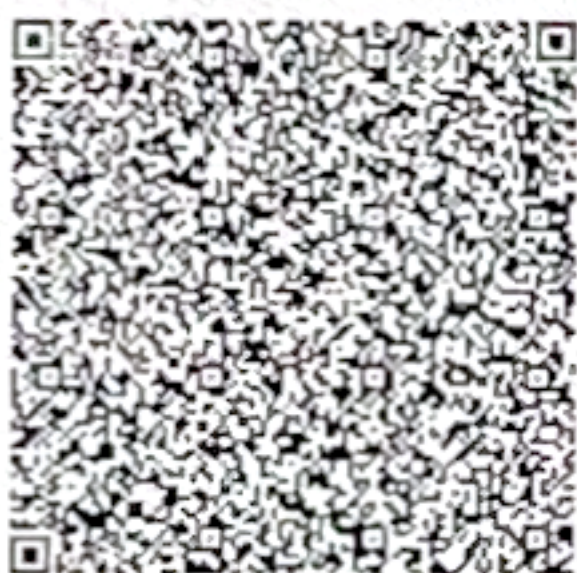

MEMORANDUM OF UNDERSTANDING

This **Memorandum of Understanding (MoU)** is executed on the Twelfth day of December, 2025 between **Guru Nanak Dev University**, functioning under the provisions of the Universities Act and located in Amritsar-143005, represented by its Registrar

AND

International Hospital Limited, Majitha Verka Bypass, Amritsar-143004, a company incorporated under the Companies Act, 1956 and having its registered office at International Memorial Research Institute, Sector-44, Gurgaon-122002, through its authorized signatory Mr. Yogesh Joshi.

Article 1: Purpose of the Agreement

- i. Guru Nanak Dev University (hereinafter called **GNDU**), established in 1969, is a reputed institute of higher learning in the country, serving the cause of National Development by offering tertiary education and conducting basic and applied research in various disciplines.
- ii. **International Hospital Limited, Majitha Verka Bypass, Amritsar** is a modern Health Care Institute, equipped with ultra-modern state-of-the-art facilities and is implementing the latest treatment techniques in the service of human health care.
- iii. Collaboration for teaching of relevant portions of the courses and for conducting structured residency (Internship) / field training/ attachment is essential for many Departments of GNDU where coursework is related to Medical Sciences, and for this purpose, a MoU with an established institution like **International Hospital Limited, Majitha Verka Bypass, Amritsar** is envisioned.
- iv. GNDU and **International Hospital Limited, Majitha Verka Bypass, Amritsar** have mutually agreed to collaborate in the teaching, conducting practicals in relevant courses, and providing required residency/field training/attachment program for various courses related to Medical Sciences.



Article 2: Implementation of the MoU

- i. The work related to the academic instructions required for various Medical Science-related courses will be conducted in the relevant Departments of GNDU/International Hospital Limited, Majitha Verka Bypass, Amritsar.
- ii. **International Hospital Limited, Majitha Verka Bypass, Amritsar** agrees to extend its facilities for conducting the practical exams as well as residency/field training/workshops/attachments, etc., free of cost.

Article 3: Restrictions and Limitations

- i. This agreement is not to be construed as a contract in law, creating a legal relationship between the two institutions. Instead, it is formulated in the interest of generating human resources in the field of Medical Sciences to facilitate and develop mutually beneficial, synergistic academic activity.
- ii. In the spirit of this agreement, each institution is considered as principal. Neither institution is authorized or empowered to act as agent for the others for any purpose or shall enter on behalf of the others into any contract or representation on any matter. Neither of the two institutions shall be bound by the acts or conduct of the other.

Article 4: Validity of the Agreement

- i. This agreement between the **GNDU** and **International Hospital Limited, Majitha Verka Bypass, Amritsar** is valid for ~~three years~~ ^{one year} as per mutual agreement.
- ii. For incorporating any modification, changes, and amendments to this Memorandum of Understanding, the written consent from both the Institutions—**GNDU** and **International Hospital Limited, Majitha Verka Bypass, Amritsar** shall be mandatory.


Article 5: Data Confidentiality and Sharing

- i. At all times, during the term of this Agreement or at any time thereafter, both parties shall take all reasonable precautions to prevent the disclosure and to protect each party's confidential or sensitive information.


