2. Rates should be inclusive of all taxes, Excise Duties, levies, Packing & Forwarding, Freight, Local Carriage etc. F.O.R. Guru Nanak Dev University, Amritsar – 143 005, otherwise quoted price will be treated as all inclusive. Rates should be written both in words and in figures.
3. The institutional discount should be mentioned clearly.
4. The Quotations shall be written legibly and free from erasing and over-writing. Corrections, if any, should be duly attested by the authorized signatory.
5. Bids received within the due date only will be entertained.
6. The quotation should be valid for a period of 60 days for acceptance from the date of opening of the bids and Bidders cannot withdraw their offer once it is submitted.

7. The Bidder/Supplier/Firm must have a valid GST registration number.
8. The warranty period should be clearly mentioned on the warranty certificate / document.
9. The committee reserves the right to accept/reject the quotations received or cancel the whole proceeding without assigning any reason whatsoever. In case of any dispute, the matter will be referred to Vice-Chancellor, Guru Nanak Dev University, Amritsar, whose decision will be binding and final. Bidders are not entitled to claim any damage or compensation in case of such cancellation.
10. Jurisdiction: The disputes, legal matters, court matters, if any shall be subject to Amritsar jurisdiction only.
11. The delivery and installation of seven Desktop Computers in the office of the Directorate of Placement & Career Enhancement, Guru Nanak Dev University, Amritsar shall be made within 15 working days of the issue of the supply order failing which the order will be withdrawn.
