

- 5 The undersigned does not bind himself to accept the lowest or any quotation and reserves to himself the right of accepting the whole or part of the quotation and the quotee shall be bound to perform the same at the quoted rates.
- 6 Head Mass Communication Department reserves the right to reject or accept any quotation or all quotations.
- 7 The bidder/supplier/Firm must have a valid GST registration number.
- 8 Quantities can be increased or decreased as per requirement.
- 9 If the due date falls on a Holiday, then the quotation will be received on the next working day.
- 10 Variation in size & shape shall be applicable as per specification/ISI code.
- 11 **Conditional Quotations shall not be entertained.**
- 12 **No advance payment shall be made. 100% of the payment will be made after supply and installation of the equipment and demonstration of satisfactory working to the satisfaction of the competent authority.**
- 13 The warranty period should be clearly mentioned on the warranty certificate/document.
- 14 Delay / loss in postal transit or due to any other reasons will not be University's responsibility.
- 15 The University will not responsible for accidental opening of the covers that are not properly superscribed and sealed before the time scheduled for opening.
- 16 Authorized signatory should sign on all the pages. Bids/Quotation without authorized signatures or seal of the firm shall be rejected.
- 17 In case of dispute, legal matter, if any shall be subjected to Amritsar Jurisdiction only.
- 18 The Delivery of Material shall be made within time period as mentioned above from issue of supply order, failing which the order will be withdrawn.
- 19 The offer shall remain open for acceptance for a period of **NINETY** days from the date of opening of the quotation.
- 20 In case the lowest bidder commits mistakes or fails to comply with the terms and conditions, the matter will be considered by committee constituted by the competent authority for appropriate action viz forfeiting of EMD, Blacklisted the firm or any other action deemed fit by the committee and the decision of committee will be binding on the L-1 firm/ lowest bidder.
- 21 The University reserves the rights to cancel the order if it is found at any later stage that the supply is not being made as per specification & satisfaction and the payment shall not be made for the received goods.
