- Technical bid shall be opened first. Price bid of contractors who qualify the technical bid shall be opened.

Information in this regard shall be given to the eligible bidders separately.

13. Incomplete Tenders/ tenders without required documents of technical bid, tender fee & earnest money are liable to be rejected.

In case the lowest bidder commits mistakes or fails to comply with the terms and conditions, the matter will be considered by committee constituted by the competent authority for appropriate action viz forfeiting of EMD, Blacklisting the firm or any other action deemed fit by the committee and the decision of committee will be binding on the L-1 firm/lowest bidder.
15. The University reserves the rights to cancel the work/supply order if it is found at any later stage that the supply/work is not being made as per specifications & satisfaction and the payment shall not be made for the received goods
16. Scanned copies of the documents only demanded in the technical bid should be uploaded and these documents should be readable after printing otherwise tender shall be rejected. No extra documents apart from demanded in the technical bid should be uploaded.
